The product or its identification tag (label) must include the type approval mark, quality mark **B500B**, name of the manufacturer, manufacturing site and type approval identification. The manufacturers mark to be rolled into the product. The manufacturers site mark is: **1/9**.

Product specification:

The products' characteristics are:

- Yield strength ≥ 500 MPa
- Relation tensile/yield $\geq 1,08$
- Ductility $\geq 5\%$
- Fatigue strength: Fulfils the requirement of Fa
- Mass fulfills the requirement
- Bond properties and rib geometry fulfill the requirements
- Weldability and long-term durability fulfill the requirements
- Bendability fulfills the requirements

The product is designed to be used for the reinforcement of load-bearing concrete structures.

The technical properties of the product have been type tested in the extent presented in standard **SFS 1300:2020**, and the Producers internal production quality control system meets the requirements of the standard.
