Place of the label: at least one label per coil.

Steel for the reinforcement of concrete is marked on the following way:




Figure 3 (only for Lampertheim) (1-39)

On two rib rows by thicken ribs, with the code (3-3), figure 2, or

on two rib rows by thicken ribs, with the code (1-39), figure 3 (only for the production site Riva Stahl, Lampertheim)

Place of the mark: on a mutual distance of \pm 1 meter. The position of the transverse ribs may also be in reverse.
